Held annually during the first weekend in November, Jump\$tart Coalition partners—from business, finance, government, academia, and the non-profit sector—work together to provide the resources, expertise, and support needed to engage, inspire, and appreciate teachers from across the country. - **November 4-6, 2023** at the Gila River Resort and Casino in Chandler, AZ
- Registration (through California scholarships) is open to Pre-K through 12th-grade California classroom educators who teach personal finance or incorporate it into any subject.
- Scholarships include prepaid registration to the conference (worth \$1,250) and up to \$600 towards travel expenses.
- The prepaid registration includes a two-night stay at the hotel, six (6) conference meals, and full participation in the conference.
- Scholarship applications are due to the California Jump\$tart Coalition on **August 4, 2023**.
